

FOREST STEWARDSHIP IN WINE COUNTRY

Saturday 14 June 2014, Glen Ellen

This workshop is intended for present and future owners and managers of forest or woodland properties in Sonoma County. The workshop will have an indoor session in the morning and field tour in the afternoon. The classroom session will be held at the Glen Ellen Fire Department, and will focus on forest and watershed health.

Researchers, foresters, and land management specialists will discuss the ecology and historical development of the region's forests and forest and watershed health. Agency representatives will describe potential funding streams available to land owners and legal tools for long-term land conservation. The field tour will emphasize applied management techniques such as shaded fuel breaks, oak establishment, and removal of fish passage barriers. Class size limited to 30 participants.
